TREATMENT METHODS

In relation to the aforementioned purposes, personal data is processed using paper, computer, and electronic means, using methods strictly related to the aforementioned purposes and, in any case, in a manner that guarantees the security and confidentiality of the data as well as full compliance with the law. The processing concerns personal data whose source may be third parties.

DATA COMMUNICATION

The recipients or potential categories of recipients are: banks and credit institutions; law firms; IT maintenance/repair companies; public bodies; self-employed, project-based, and occasional workers. The data will not be disclosed.

RETENTION PERIOD

The retention period for personal data used for contractual purposes coincides with the duration of the contractual relationship; while the retention period related to fulfilling legal obligations is prescribed by law.

RIGHTS OF THE INTERESTED PARTY

Data subjects have the right to request from the Data Controller access to their personal data and to rectify or erase it, limit the processing of their data, or object to such processing (Articles 15 et seq. of the GDPR). Data subjects, where applicable, have the right to lodge a complaint with the Data Protection Authority, as the supervisory authority.

DATA PROVISION

We also inform you that providing your personal data is a legal or contractual obligation or a necessary requirement for entering into a contract. Therefore, you are obligated to provide your personal data, as failure to do so will make it impossible to manage the existing pre-contractual relationship.
